

## **COMPETITOR CONSENT FORM**

1. i undertake to take out my own personal health insurance during my stay in Leipa/Germany within the event ICF worldchampionchips canicross bike scooter 2023.
2. i confirm that my training and health condition meets the requirements of the competition. I am informed about the health and other dangers and circumstances associated with the competition and expressly confirm to participate in the event at my own risk.
3. i affirm that my starting dog(s) are in a suitable training condition. I have read the doping regulations for dogs and hereby expressly accept them.
4. at the same time I assure that I will not make any legal claims and demands on the organizer, his employees as well as the participating clubs, communities and other persons and corporations, as far as there are no liability insurance claims. This includes all direct and indirect damages as well as all claims that I, my heirs or other entitled third parties may assert due to injuries suffered or in the event of death.
5. i agree that i will not hold the ICF, the organizing national association VDSV, the local organizer SSV Sachsen, other local authorities, the organizers, their helpers or the sponsors liable for any injuries, accidents or damages to me, my dog handlers, my dogs, my vehicle or my other equipment carried.
6. i acknowledge that i am bound by all the provisions of the ICF Rulebook as well as the WADA Anti-Doping Rules and the International Standards issued by the World Anti-Doping Agency and published on its website, and confirm that i have read, understood and will comply with them.
7. I agree to abide by all decisions made by the Race Director during the event. In the event of a conflict between me and my national federation, the ICF, the host national federation VDSV, the local authorities, the local organizer and/or the sponsors regarding my participation in the event, I agree to pursue the matter only through the legal provisions of said bodies.
8. i acknowledge the authority of the ICF, my national federation and/or the National Anti-Doping Organization (NADA) to conduct doping controls, administer results and impose sanctions in accordance with the WADA or NADA anti-doping rules.
9. With my registration I agree to the storage of my personal and event-related data. I agree that the collected personal data will be passed on to third parties for the purpose of timekeeping, creation of result lists as well as the posting of these lists on the Internet. I agree to the publication of my name, first name, year of birth, nationality, start number and my results (placements and times) in all print media relevant to the event (list of participants, list of results, newspapers, etc.) and in all electronic media such as the Internet, TV and television.

I agree that the data mentioned in my registration as well as the photos, videos and film recordings made by me on the occasion of my participation in the ICF Worldchampionship 2023 Leipa may be used in the context of the reporting of the event and for the advertisement of this event without any claims for remuneration on my part. This does not apply to commercial use.
11. with my registration I declare conclusively that I have carefully and in detail read through and understood this waiver, release and obligation declaration and that I expressly agree with its contents.
